Comments by the authors: Rehabilitation services should learn from earlier coronavirus outbreaks and prepare for the aftermath of Covid-19

The meta-analysis paper comes from an experienced team of researchers from Leeds, Manchester and Hull in the United Kingdom. This is the first paper in the literature to collate evidence on long-term physical, functional, psychological and social impacts among patients who fell victim to Severe Acute Respiratory Syndrome (SARS) and Middle East Respiratory Syndrome (MERS) coronavirus outbreaks. These outbreaks resulted in respiratory and exercise capacity problems in the first six months after hospitalisation, mental health problems including post-traumatic stress disorder, anxiety and depression in up to a third of survivors beyond six months with quality of life in a third of them being impaired even 12 months after discharge from hospital. Rehabilitation clinicians and services should anticipate similar health problems in the survivors of COVID-19 and plan interventions to maximise their functional recovery. Read more

Comments by the authors: The main goal for this study was to determine whether hypermobile adolescents with chronic musculoskeletal pain profit from multidisciplinary rehabilitation treatment consisting out of a combination of physical training and cognitive-behavioural therapy (exposure *in vivo*). After treatment, adolescents experienced less disabilities, lower levels of pain-related fear and pain intensity, and increased muscle strength and motor performance. These results are promising, however the findings are based on a small sample size without a randomized controlled group. Therefore, the results should be interpreted with caution.
