*Comments by the authors:* The two case reports in this article demonstrate how a multidisciplinary early rehabilitation intervention in an acute hospital can be effective in improving function in morbidly obese patients post sepsis. The cases illustrate the challenges faced by rehabilitation providers, and the role that in-reach teams can play in assisting with the rehabilitation process. With the increase in the prevalence of obesity globally, there is a need for structured rehabilitation interventions in the acute hospital setting to prevent and reverse functional deterioration. Structured rehabilitation interventions can also help the community to prevent functional decline prior to health problems that may require hospital admission. [Read more](#)
